The final assessment will be an open-book take home assignment administered on the D2L quiz tool. You will have 42 hours to complete it. It will be 20 multiple choice questions. The bonus questions will be open ended. Please note that this final assessment is now weighted to 10% instead of 20%. 10% of that weightage is shifted to the individual project. The final assignment will run from Friday, April 17th 11 AM to Sunday, April 19th 11 AM.

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

The conversion between a percentage grade and letter grade is as follows.

The Department will arrange for a reappraisal of the work within the next ten business days. The reappraisal will only be considered if the student provides a detailed rationale that outlines where and for what reason an error is suspected.
