Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

At the start of the term, you will be asked to complete a series of four exercise sets using the online homework system *WeBWork*. These exercise sets have been created to enable you to practise the material appearing in the **Online Module** folder (beneath **Contents**) in the DATA 602 D2L Page. These online assignments are worth a total of 5%, 1.25% for each. Each of these exercise sets go live on **January 9th at 8:00AM. You have until January 15th 11:59PM to complete these exercise sets.** Excluding a handful of exercises, you have an unlimited number of attempts for each exercise set.

You will be given a series of assignments (4) which are based on the material covered. These assignments are based on the lecture material and will be submitted via a Dropbox folder provided within the DATA 602 D2L page.

Assignment problems can be worked on either individually or in groups. Your assignment write-ups should be your own work and must be completed in **R Markdown** and submitted as a .pdf file.

R Markdown is a platform that can be used to communicate any piece of written work. It incorporates normal text, html, LaTeX, and "chunks" of R code in an all encompassing document. This document was created with R Markdown. For more information please consult the [R Markdown page](#).

The reappraisal will only be considered if the student provides a detailed rationale that outlines where and for what reason an error is suspected.
