These projects included master planning; financing; achieving approvals for development; land development; construction of resort accommodation, residences, commercial operations, and related infrastructure; real estate sales; and operations. He was also responsible for building major resort and residential projects in Waterton Lakes National Park and Sun Peaks Resort.

Bellstar provided vision, management and financial resources for the planning, development and management of the internationally acclaimed and awarded 226-unit Spirit Ridge Vineyard Resort & Spa on Osoyoos Indian Band lands near Osoyoos, B.C. Ed was also in charge of the Residences at Spirit Ridge, a low-density multi-family development currently under development adjacent to Spirit Ridge Vineyard Resort & Spa. Spirit Ridge is uniquely located in Canada's only desert region next to Nk'Mip Cellars, vineyards, Sonora Dunes Golf Course, Lake Osoyoos and the Nk'Mip Desert Cultural Centre. In its second year of operation in 2007, Spirit Ridge Vineyard Resort & Spa achieved a 4.5 Star Canada Select rating. In 2013, Spirit Ridge was named the #1 Fractional Resort in North America.
- ➤ Ed was the developer and founder of Waterton Lakes Lodge in Waterton Lakes National Park (sold in 2000), founder of Royal Tours in Alberta (sold in 1991), and the Principal in charge of the Edmonton office of Pannell Kerr Forster Management Consultants. - > During his management consulting career, both as an independent and as a Manager/Principal of Pannell Kerr Forster (PKF), Ed was in charge of feasibility studies, valuations, financings and plans for wide range of businesses

- with a focus on resorts, hotels, attractions and tourism businesses throughout Alberta, B.C., Saskatchewan and the Northwest Territories in Canada. A good portion of these businesses were in smaller communities, on First Nations' lands, and in environmentally sensitive areas.
- > In addition to his experience in community development and the hospitality industry, Ed has led the development of complex multi-use projects from initial site selection and planning through to commissioning and operations.
- > Ed was the project manager for the development of the Calgary French & International School, and the Edge School & Sports Complex near Calgary.
- > Ed was educated in planning, engineering, architecture, valuations and real estate development in Canada and the U.S. His education includes a Bachelor of Arts Honours (BA Honours) from the University of Winnipeg, and a Master of City Planning (MCP) from the University of Manitoba.
