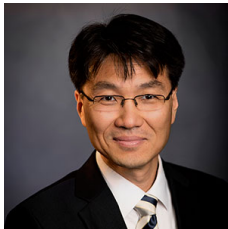

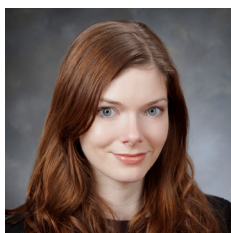

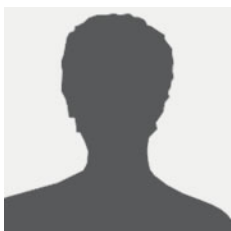

Kristen van de Biezenbos, Assistant Professor, Law and BSEN. Kristen's research explores energy law and its local impacts, especially the problems of externalized costs and regulatory gaps. She also writes about energy in context with water law and land use issues, global energy initiatives, international energy transactions, and comparative energy policy. She has a particular interest in offshore energy projects, both hydrocarbon and renewable, and related issues. Before joining Haskayne in 2017, Kristen taught energy law and related courses at the University of Oklahoma College of Law and Texas Tech University School of Law. She received her JD from Tulane University Law School in 2010 and interned for the honourable Judge Lance Africk at the US District Court for the Eastern District of Louisiana. She subsequently had a mixed transactional and litigation practice in New Orleans, focused on offshore energy services, maritime law, and international arbitration. From 2013 to 2015, she was a Westerfield Fellow at Loyola University New Orleans College of Law. She also holds a BA from the University of Tennessee and an MFA from the University of New Orleans.



Miguel Palacios, Assistant Professor, FNCE. Miguel's academic work focuses on the intersection of human capital and asset pricing. In particular, he studies the size and riskiness of human capital, and measuring the effect it has on the riskiness of firms. He also works on alternative instruments for financing education. Conference Hosting



Alain Verbeke and **Olga Petricevic** organized a Strategic Management Society (SMS) Special Conference together with David Teece, one of the thought-leaders and the most cited scholar in the field of strategy, from the University of California, Berkeley.

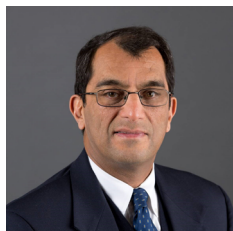
The conference was held at the beautiful Rimrock Resort Hotel in Banff National Park from June 2-4, 2017. The conference brought together close to 250 prominent scholars from every corner of the world, to explore the conference theme “Transforming entrepreneurial thinking into dynamic capabilities” along four different conference tracks. The thought-provoking and energizing program was organized into 27 parallel sessions, in addition to the Doctoral Workshop, Meet the Editors Panel, and three Featured Plenary Sessions. Two Doctoral Workshop Co-Chairs together with five senior scholars in the field engaged with fifteen PhD students from leading national and foreign research universities to help them advance their doctoral dissertation research. Editors representing the SMS journals, as well as other leading scholarly outlets, engaged in a dialogue on how to publish research in top journals. President Cannon welcomed the attendees, and very vividly and powerfully described in her opening remarks how a dynamic capabilities approach has guided the University of Calgary’s ‘Eyes High’ strategy, and has contributed to the University of Calgary being recognized as the ‘Number One Young University in North America.’ Dean Jim Dewald compellingly outlined how the dynamic capabilities approach had inspired his own research and his daily managerial practice. During the three plenary sessions, high-profile scholars such as John Roberts (Stanford), Birger Wernerfelt (MIT), Jay Barney (University of Utah) and Shaker Zahra (University of Minnesota), delivered impactful keynotes on transforming and emboldening research approaches in both entrepreneurship and strategy, and engaged the audience in a lively interdisciplinary dialogue. Against the awe-inspiring backdrop of the Rocky Mountains, the social events highlighted Canada’s and Alberta’s entrepreneurial and adventurous history, and allowed for genuine intellectual exchange of ideas and novel research opportunities. The attendees rated the conference as the most successful Special Conference organized by the SMS to date, with a 96% satisfaction score.

The organizers are grateful to Dean Dewald for his unwavering support of this important initiative, and to Kim Neutens and the Hunter Centre for Entrepreneurship and Innovation for the generous funding of the student-focused components of the Conference. The Special Conference’s success was also greatly helped by the Haskayne School’s event team, which did a magnificent job in attending to all conference details, and ultimately made the difference between what could have been a good event, but turned out as a great event!

It is expected that the conference will be instrumental to a publication initiative in an AJG 4*/FT-50 journal in the near future.
