

HASKAYNE BACHELOR OF COMMERCE <u>TRANSFER PROGRAM</u> FALL 2019 ADMISSION

- It is the student's responsibility to be aware of all University of Calgary Academic Calendar regulations associated with the Bachelor of Commerce (BComm) degree program and courses.
- Combined degree students may have different course requirements and recommended sequence. Please consult advisors in both faculties for program details prior to registration.
- Ahead of registration, students are cautioned to consult course descriptions in the University of Calgary Academic Calendar.
- Register for <u>BOTH the Fall AND Winter terms</u> on your registration date and ensure you have the stated prerequisites for courses in each term. Final requisite checks are conducted by the Undergraduate Programs Office.
- Students must successfully complete 18.0 units in 200-level courses prior to registering in 300-level and above courses.
- Bachelor of Commerce students require a Letter of Permission to register in courses offered by another institution. The Haskayne specific guidelines are available at http://haskayne.ucalgary.ca/programs/bcomm/student-forms.
- To complete the BComm degree program, all 40 courses (or 120.0 units) listed below must be successfully completed.

These courses need not necessarily be taken in the sequence indicated. Students should consult the University of Calgary Academic Calendar for course descriptions and pre- or co-requisites.

- A Junior-level University English is required for transferring into the BComm degree program, and students who delayed completing it in their first year may have difficulty registering for it in a later year due to registration restrictions.
- ² MGST 217, SGMA 217, and ACCT 217 should be completed together in the first term of admission to the BComm program, to ensure that prerequisite requirements are met for upcoming courses.
- ³ Students pursuing the Accounting concentration should enroll in ACCT 217 in the Fall term of Year 2 and ACCT 323 in the Winter term of Year 2, and plan to defer one of the Senior Non-Commerce Options to a later year.

- ⁵ Students who wish to pursue the research-based BComm Honours program are recommended to take both DATA 201 and UNIV 201.
- ⁶ Students who wish to pursue the International Business Strategy concentration are advised that demonstrated proficiency equivalent to two courses in ONE modern language other than English is a requirement. Students with an equivalent background should first consult with the Haskayne Undergraduate Programs Office for approval.
- Organizational Behavior and Human Resources 317, Marketing 317, Operations Management 317. Until 60.0 units or more have been successfully completed, a maximum of three of these Core 317 courses can be taken.

 $^{\rm 8}$ Concentration courses are listed on the second page of this document.

A maximum of 12.0 units with "D" or "D+" grades in non-concentration and non-prerequisite courses will be permitted.

A minimum grade of "C-" is required in any prerequisite course, junior English, Management Studies 451, Management Studies 453, Strategy and Global Management 591, and in each course permitted to fulfill the concentration requirements. If the course serves as the prerequisite to the concentration sought, then it must be a "C" grade or higher.

Students must complete the following courses or their equivalents for graduation within 10 years or less of the graduation date or consult with a Haskayne Student Advisor: Junior English, Mathematics 249 or 265, Economics 201 and 203, Statistics 213 and 217, and all Commerce courses.

The following business courses are \underline{NOT} available for credit towards the BComm degree: ENTI 201, ACCT 301, BSEN 401, FNCE 341, FNCE 343, OBHR 321, BTMA 321, MKTG 341, OPMA 301, and TOUR 409.
