



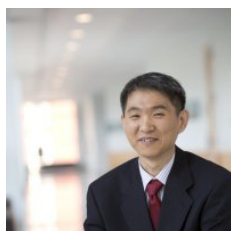

Seok-Woo has amassed an impressive 9,085 citations (Google Scholar), driven largely by his co-authored seminal article entitled “Social Capital: Prospects for a New Concept” in the *Academy of Management Review*.

Conference Hosting and Service

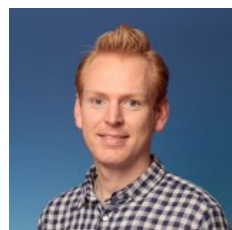

Leo also received a \$10,000 Pre-Dissertation PhD Scholarship from Spencer Educational Foundation.



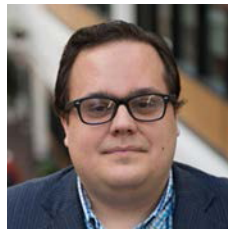
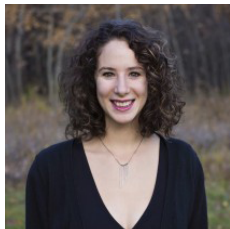
Soonchul Hyun received a \$12,000 Eyes High International Doctoral Scholarship,
