

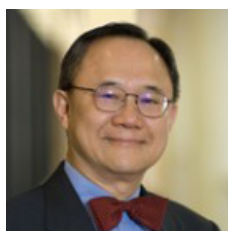

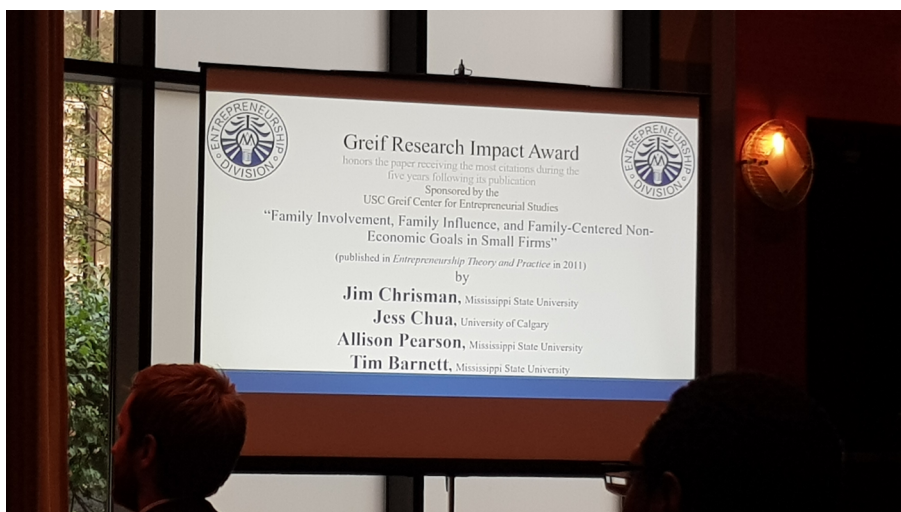

The University of Southern California Greif Center for Entrepreneurial Studies awarded **Jess Chua** and his co-authors the Greif Research Impact Award in 2018. This is a \$5,000 annual award given to the researcher(s) who published the most impactful entrepreneurship article six years ago in the top management and entrepreneurship journals. Impact is measured as the number of Social Sciences Citation Index citations in the five years following publication. The award was presented at the Academy of Management meeting in August 2018. “Program on Machine Learning in Quantitative Finance and Business Analytics”

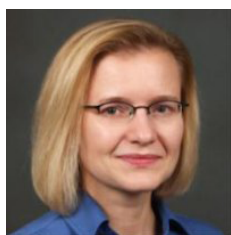
This multidisciplinary training program will fund approximately 24 undergraduate and 80 graduate students over the next 6 years to acquire specialized skills in the field of innovative machine-learning technology in quantitative finance and financial business analytics. The program will deliver a new generation of finance professionals to meet the modelling and implementation needs of the quantitative spectrum in the Canadian financial industry and contribute to its global competitiveness. Our training program revolves around a collaboration between experts at six Canadian academic institutions (University of Montreal, HEC Montreal, Concordia University, University of Calgary, University of Waterloo and Queen’s University) and several industrial partners in three geographical locations (Calgary, Toronto and Montreal).

Update on SSHRC Partnership Development Grant Progress:

In August 2018, **Anne Kleffner** and **Tatiana Vashchilko** began field research in Turkey and Tunisia on their three-year SSHRC-funded Partnership Development Grant with co-applicant **Martin Halek**, “International Business in the Middle East and North Africa (MENA)” awarded in March 2018. Four of five co-investigators on this project, Andreea Mihalache-O’Keef (Roanoke College), Ekrem Karakoc (SUNY at Binghamton), Anne Kleffner and Tatiana Vashchilko travelled across four cities in Turkey and Tunisia to interview public officials and managers about opportunities and challenges that businesses may encounter in the MENA region.
