For University of Calgary Change of Program Applicants

The University of Calgary acknowledges and respects the rich diversity of learners, their communities, cultures and traditions, and their aspirations and abilities. To ensure equitable access and successful participation of Indigenous learners, the Haskayne School of Business offers an Indigenous Admission Process and an Indigenous Admission Pathway for students of Indigenous identity.

To be eligible for consideration students must:

- Be an Indigenous person of Canada (First Nations (Status or Non-Status), Métis, Inuit).
- Complete the Change of Program application by February 1st.
- Submit the Signed Statement (below), by <u>February 1st</u>.
- Submit a **Personal Statement** (oral, written or video) by February 15th.
 - The Personal Statement is only required for students applying for admission under the Indigenous Admission Pathway. It should outline education goals and explain how past education, cultural knowledge, life and work experiences will enable success in university studies. Writing Support for Indigenous Students is available at the Writing Symbol Lodge or at the Student Success Centre.
 - The Signed Statement and Personal Statement can be submitted to Haskayne Undergraduate Student Services in person at MTH 424 or via email to future.bcomm@haskayne.ucalgary.ca.
- Submit Indigenous Identity documentation (see last page for recognized documentation) by March 1st.
 - o Indigenous identity documentation can be submitted to Haskayne Student Services in person at MTH 424 or via email to future.bcomm@haskayne.ucalgary.ca.

Personal Statement:

Applicants who wish to be considered under the Haskayne Indigenous Admission Process/Pathway must complete and submit a Personal Statement which should outline education goals and explain how past education, cultural knowledge, life and work experiences will enable success in university studies.

Students are not expected to share details about private or traumatic events in outlining their situation.

The Personal Statement is intended to aid the Haskayne Indigenous Pathways Admissions Committee in their review of your application for admission within the context of your lived experience. You may respond in the format of your choice (oral, written or video). Written statements should be between 250-300 words per section, and video or audio submissions should be between 2.5 to 3 minutes in length per section.

Writing Support for Indigenous Students is available at the Writing Symbol Lodge or at the Student Success Centre.

Additional documentation can also be submitted in support of an application under the Indigenous Admission Process. If you choose to provide letters of reference, they should be from respected community members, who are both familiar with your situation and able to support the information detailed in your Personal Statement below.

Section 1: Personal Circumstances and Barriers

Please describe the personal circumstances, systemic barriers, or lived experiences that have shaped your path to post-secondary and led you to apply through the Indigenous Admission

Supplementary Process. You may consider the following prompts to guide your response:

- What are your educational goals, and how do you plan to succeed in your chosen program?
- What educational, cultural, personal, or work experiences have prepared you for university studies?
- What challenges or barriers have affected your access to or experience with university studies?
- What strengths, supports, or resources have helped you navigate these challenges?
